Table of Benefits with Work Permit Cover Extension

This policy is designed to provide benefit for investigations and treatment of **football-career threatening injuries** which arise after the date of joining the policy, **during team practice sessions, scheduled games and tournaments organised by the Malta Football Association.**

Although the applicable Area of Cover is Malta, we will pay for treatment in hospitals/clinics worldwide up to the fair and reasonable costs applicable for treatment in Malta. Direct Settlement will not apply for overseas treatment. Please refer to the Policy for further benefit details and terms and conditions of cover. The Policy may be viewed online at www.laferla.com.mt. **Under this scheme, the Exclusion in the Policy relating to 'Injuries arising from taking part in sporting activities' will be waived.**

It is highly recommended that any **In-Patient or Day-Case treatment is done at St. James Hospital** who are the preferred providers for this scheme.

Important Note: We will not pay for the first €25 of each Out-Patient claim and the first €200 for each In-Patient Claim. For the purpose of this Excess notice, a "claim" will refer to a full course of treatment for one injury. In case of In-Patient claims, You may be requested by the hospital to settle €200 immediately, with the remainder being billed to Laferla for direct settlement (up to the applicable limits).
